VA's New Mission Act. If you participated in the Choice Health Care Program, be advised that program has ended and been replaced with the Mission Act. This new program is designed to allow Veterans to receive care in a community clinic/hospital of their choosing. To be eligible you must be enrolled in VA health care and have been seen by a VA Primary Care Provider in the last 24-months. As this program is very new, both VA staff and Veterans Advocates are learning together how to make the system work. The best option is for you to call your VA Primary Care Provider and ask them for a "referral" to the clinic you wish to receive treatment. Avera & Mayo are NOT taking VA patients. This is NOT for Emergency Room visits. In the event you have an emergency room visit, your statement to the E/R should be: "I am a VA patient, please call their doctor-to-doctor phone and ask that I be transferred there." Doctor-to-Doctor numbers are: 1. Minneapolis: 612-467-2019, St. Cloud: 320-252-1670, extension 7020.
