Veterans Day on the Hill will be on April 20. Call John or Greg at 507-233-6636 to reserve your seat on our motor coach that departs the Courthouse at 8 a.m. Sharp! The events will start by our arrival to the Cedar Street Armory where a free lunch will be served. We have already invited Senator Dahms, and Rep. At 12:45 the group will be led by bagpipes and march to the Capitol Rotunda where Post 132 Legion Rider and Department Chaplain Betty Jass will give the invocation.
